Why can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday business purposes—information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply by everyone on the account - unless you tell u otherwise.
Definitions	
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. Hourglass Management, Flexco Fleet Services, E Fleet Direct, Innovative Funding Services Corporation, ZOOMWAREHOUSE
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. Tresl does not share with nonaffiliates so they can market to you.
Joint marketing	 A formal agreement between nonaffiliated financial companies that together market financial products or services to you. Avis Budget Car Rental, LLC Mercedes Benz USA
